 - 2.1 None.
- 3. <u>Public Participation / Question Time.</u>
 - 3.1 Mr and Mrs Wilmot of 37 Abbots Rise were present to speak regarding planning application 4/00957/17/FHA to which the committee had objected at its meeting of 16th May 2017.
 - 3.1.1 Mr Wilmot stated that he had worked closely with Dacorum Borough Council's Planning Officer and that the application was similar to many of the extensions that had taken place on the estate and was within Permitted Development, apart from raising a ridge 300mm, with which the Planning Officer was happy. Mr Wilmot asked the Committee whether it would reconsider its objection. The Clerk added that he had been informed by the Planning Officer that she would be recommending that the application be granted.
 - 3.1.2 Members were still concerned with overdevelopment, not only of the plot, but also of the whole of the estate, where it was becoming dense. However, it was AGREED that the Council would amend its submission to "Noted".
