- 6. <u>Any Other Business</u>.
  - 6.1 There was further consideration of the situation regarding planning application 4/01355/16/FHA (75, Watford Road) for the "Formation of Vehicular Access onto Watford Road" which was refused by Dacorum Borough Council, mainly because of objections by the Highways Authority, and also dismissed on appeal to the Planning Inspectorate, but which appeared to have been created regardless, and was, therefore in breach of the planning decision. The Clerk and Cllr Anderson reported that there appeared to be a reluctance on the part of Dacorum Borough Council's Enforcement Officer to act. Further action was under consideration.
  - 6.2 It was noted that Dacorum Borough Council's updated Local Plan / "Options" was still awaited.
