MINUTES of the Meeting held on Tuesday 17th October 2017 at the Council Hall, Charter Court, Vicarage Lane, Kings Langley.

- 1. Apologies for Absence.
 - 1.1 Cllrs Anderson, Button and Johnson.
- 2. Declarations of Interest.
 - 2.1 None.
- 3. <u>Public Participation / Question Time.</u>
 - 3.1 Several residents, including Mr Wray of Wayside Farm, Mr Faulkner, High Street and Mrs Hall, Hempstead Road raised their concerns regarding proposals to develop the Green Belt in and around the village.
 - 3.1.1 Mr Wray also cited occasions when assurance he had received about developments affecting his farm had been reneged upon and he had a deep mistrust regarding the current situation.
 - 3.1.2 Cllr Rogers responded in support of Mr Wray, adding that, the Parish Council did not know any more about the Dacorum Plan than was available to the public and would obviously be considering its position in due course.
 - 3.1.3 Cllr McLean responded that Dacorum Borough Council's Cabinet would be making its decision this evening on whether the new plan would go forward in its current form. He added that the previous incarnation of the plan (2015) did not include any development of the Green Belt, although this Council had reluctantly acknowledged that a small development of 35 houses could be allowed on the existing footprint of the old barns on Rectory Farm.
 - 3.1.4 Mr Wray added that the Government had recently relaxed the rules on Green Belt development.
