- 2.1 Cllr Johnson declared a Personal Interest in application 4/01670/18/FUL (20, Havelock Road) as he knew the applicant.
- 3. <u>Public Participation / Question Time.</u>
 - 3.1 Cllr Johnson had been asked by Mrs Cheryl Sharma of Hempstead Road to ask four questions under this item and these are shown below with the Council's responses:
 - 1. Question: "Do our Parish/Borough Councillors support the 99% of parishioners that voted against greenbelt development?" Response: Yes.
 - 2. Question: "What are they doing to implement the will of the electorate, expressed by the village poll that was organised by the parish council at a cost of thousands of pounds of public money?"

 Response: At this stage no plans have been submitted for Green Belt development". Note (Cllr Anderson): the poll was "called" by electors at a meeting organised by the Council and it did not cost "thousands of pounds".
 - 3. Question: "Are they aware of any plans to build on, or declassify, the greenbelt land at Rectory Farm?"

 Response: Phase 2 of Angle Property's outline proposals for its Rectory Fam
 - 4. Question: "Do they [our Parish/Borough Councillors] support development of the greenbelt at Rectory Farm?" Response: No.
 - 3.2 Cllr Johnson undertook to convey the Council's responses to Mrs Sharma.
