- 9.2 Further concerns were raised regarding activities at "The Trout Lake" in Home Park Link Road". Cllr Anderson reported that he had already emailed Planning Enforcement at the Borough. There was some discussion about employing a drone operator to film the area, but it was agreed to await the outcome of the Borough's actions.
- 9.3 Cllr McLean asked whether Members felt that "The Repair Shop" which was being displaced from Rectory Farm could make use of the former toilets in Dronken Lane. Members had no objection in principle to this idea. Cllr Anderson provided Cllr McLean with contact details at the Borough.
- 9.4 Cllr McLean reported that an update on Dacorum Borough Council's Local Plan had been issued earlier in the evening. Cllr Anderson added some further information and was concerned with the lack of a statement regarding protecting the Green Belt. Cllr Rogers asked if the proposed "Hemel Garden Village" was included in the numbers of units that Dacorum Borough Council was expected to provide. Cllr Anderson confirmed that it did.
- 9.5 Cllr Button asked if there was any clarification regarding proposals for a crematorium in Bunkers Lane, which Cllr Anderson provided, explaining that the crematorium in Garston could not always satisfy demand and that there was also a need for another cemetery as the one at Woodwells was becoming full.
