20/01409/FHA	South Wood Common Lane	Single storey front extension, single and two storey rear extension, increase in ridge height and rear roof extension to facilitate loft conversion.	Noted	Given the "sensitivity" of the area, the Council was surprised that there had been no comments from neighbours and was, therefore, concerned that they may not have been consulted.
