#### 5. Other Matters.

- 5.1 Dacorum Borough Council.
- 5.1.1 Dacorum Local Plan (2020-2038) Emerging Strategy for Growth Consultation.
- 5.1.1.1 A summary document had been issued with the agenda. Whilst some Members had taken the opportunity to examine this and the other documents on-line, Cllr Anderson suggested that, as the closing date for comments is not until the 7th February 2021, this item be placed on the main Council agenda in January (and February, in needed) to allow the Council time to formulate comments if it so wished. This was agreed.

- 5.1.2.1 Although this item was issued to Dacorum Borough Council Ward Members only, it was agreed that the Council would give it full consideration at its next Planning & Licencing Committee meeting and submit comments if considered appropriate.
- 6. Any Other Business (not requiring formal decision).
  - 6.1 Cllr Button asked whether the Enforcement Team had picked up any of the outstanding items in the village yet, in particular that at "The Trout Lake". The Clerk responded that there was no news and that it was unlikely that there would be soon on the issues in the High Street / Hempstead Road, but that he would follow-up "The Trout Lake" case.
