What does a Neighbourhood Plan do?

 Gives communities the chance to <u>decide</u> how their local area should develop and the style of what should be built

• <u>Powerful</u>: once 'made' the neighbourhood plan becomes part of the development plan

 Needs to be in <u>general conformity</u> with the strategic policies of the Dacorum Local Plan

What's the connection between our Neighbourhood Plan and the DBC Local Plan?

- The DBC Local Plan is a strategic plan for the whole borough so cannot cover all the local detail that is so important to us in Kings Langley
- When finally adopted, our Neighbourhood Plan becomes a chapter of the Local Plan focussing on what we would like to see in Kings Langley

It's not about choosing sites for new development – that's with Dacorum

 By embedding design codes in the plan we can influence the style of any new building

We can protect green space

Define what makes up local heritage and secure it



Policy KL19: Allotments and Community Growing Spaces (Page 57)	Require all major developments to provide for new allotment and/or Community Growing spaces.
Policy KL20:The Provision of Accessible Public Toilets (Page 588)	Support the provision of accessible public toilets within the Village Centre.
