- 9. <u>Any Other Business (not requiring formal decision).</u>
  - 9.1 Cllr Anderson reported that the planning applications for 36 Belham Road, 21/03881/FHA and 21/03882/LDP, to which the Council had objected, had been withdrawn and refused respectively. This would normally result in a re-application.
  - 9.2 Cllr Angiolini reported that there was a considerable amount of activity at 21 Abbots View (21/04264/LDP), to which the Council had objected, including demolition and delivery of building materials, despite there being no decision as yet from the Borough on the application. The Clerk had alerted the Enforcement Team who had responded that there were no grounds for enforcement.
  - 9.3 It was noted that application 21/03742/FHA (Amended)(17 Vicarage Lane), to which the Council had objected, had been approved by the Borough's Develop Management Committee the previous Thursday. Cllr Johnson was thanked for attending the meeting and presenting the Council's objections.
