- 9. <u>Any Other Business (not requiring formal decision).</u>
  - 9.1 Cllr Button raised a request that the Council had received from Angle Property "to attend the Parish Council meeting on 1<sup>st</sup> March to update and brief parish councillors on the latest proposals for Rectory Farm prior to launching a public consultation process". Members discussed this at length and concluded that the most appropriate arrangement would be for the update to take place during the main meeting as part of Public Participation (item 3 on the agenda). The Clerk would inform Angle Property accordingly. It was understood that it would need to be made very clear that this would not be a "planning application" discussion.
  - 9.2 The Council had also been approached by consultants for Redington Developments Apsley Ltd regarding their "emerging proposal to transform the vacant brownfield site at Network House, off of London Road, Apsley"," the site was formerly owned by Hertfordshire County Council". The Clerk had replied that he was aware that there may be a meeting with Dacorum Borough Council officers and Cllrs Anderson and Johnson, and that he would prefer to await its outcome before taking the request any further
  - 9.3 The Clerk advised that he understood that the Case Officer for the latest application for 1 The Orchard, to which the Council had objected was mindful to recommend refusal.
  - 9.4 Cllr Rogers asked whether the activities of the day nursery at the bottom of Vicarage Lane was causing any issues with traffic etc and whether the Council had any ideas of numbers. Cllr Button and the Clerk responded that they had not been aware of any issues but that the numbers appeared to be lower that had been expected / feared. Cllr Button added that the Council would be carrying out a pedestrian and vehicle count at the bottom of the road as part of the Transports Group's initiatives.
