MINUTES of the Extraordinary Council Meeting held on Tuesday 24th January 2023

1. Apologies for Absence.

3. Financial Year 2023-24

3.1 **BUDGET.**

- 3.1.1 Final version of the budget for the financial year 2023-24 had been circulated with the agenda and had previously been considered and supported at the Council meeting on 10th January 2023.

- 3.1.2 It was proposed (Cllr Johnson), seconded (Cllr De Silva), and RESOLVED that:

The finalised budget for financial year 2023-2024 be approved and adopted.

3.2 **PRECEPT.**

- 3.2.1 It was proposed, seconded, and RESOLVED,

That the Council of the Parish of Kings Langley under Section 41 of the Local Government Finance Act 1992 hereby gives notice to Dacorum Borough Council that in respect of the financial year beginning on 1st April 2023 it requires the PRECEPT sum of **£130,095.00** to meet the expenses of the Council and it hereby requires the levy of the said PRECEPT sum as an additional item of the Council Tax for the Parish and it requires this sum to be paid to Kings Langley Parish Council by 30th April 2023.

- 3.2.2 Cllr Anderson requested an amendment be made to this as follows:
To request that Dacorum Borough Council accepts the change of the precept to 0% and varies the total precept to ensure that the band D precept remains unchanged, in case the resource base changes at the last minute.
